



## Eltech August 2025 Web Order Competition Terms and Conditions

1. Information on how to enter, the collection of personal information and prizes forms part of these conditions of entry. Entry into the competition constitutes acceptance of these terms and conditions.

3. Entry is open to Australian residents who work for an Eltech customer. The directors, management and employees of the Promoter (and their immediate families) and its suppliers are not eligible to win any prizes.

4. The competition commences on Friday, 1 August 2025 at 12:01 AM AEST and closes on Sunday, 31 August 2025 at 11:59 PM AEST (**Promotional Period**).

5. To enter the competition, entrants must, within the Promotional Period, visit [www.eltech.com.au](http://www.eltech.com.au) and:

(a) Place an online order valued at over \$350 (exclusive of GST and shipping) to gain one (1) entry.

The competition is a game of chance. Entrants can enter multiple times. There is no limit on the number of entries per person. Entries are deemed to be received at the time the order is submitted during the Promotional Period.

The Promoter accepts no responsibility for late, incomplete, incorrectly submitted, delayed, illegible, corrupted or misdirected entries, claims or correspondence whether due to error, omission, alteration, tampering, deletion, theft, destruction, transmission interruption, communications failure or otherwise.

The Promoter reserves the right to verify the validity of entries and entrants (including the entrant's identity) and to disqualify any entrant who submits an entry that is not in accordance with or breaches these conditions of entry, who tampers with the entry process or who submits an entry that the Promoter, in its sole discretion deems to be not in keeping with the spirit of the competition. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter reserves its legal rights to recover damages and/or other compensation from a person whom is in breach of these conditions of entry or whom engages in any unlawful or improper conduct calculated to jeopardise the fair and proper conduct of the competition.

If the competition is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law, and subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the competition as appropriate.

The Promoter shall not be liable for any loss or damage whatsoever which is suffered (including, but not limited to, indirect or consequential loss and including equipment/communications line/telephone/mobile or satellite network failure, theft or destruction or unauthorised access (including by electronic means) to or alteration of entries) or for any personal injury suffered or sustained in connection with any entry or the Prize/s except for any liability which cannot be excluded by law.
